- f. Mayor Mink requested Fire Chief Wagner that all new members of the fire department be introduced and approved by the Shortsville Village Board. Chief Wagner will abide by this and make arrangements to have the latest members meet the board. The board also requested to have a copy of their license and application on file at The Village Hall.

- h. Resolution to re-levy unpaid taxes in the amount of \$16,834.48(see attached)
- i. A motion was made by Trustee Lonneville ,seconded by Trustee Trimm to approve the resolution to increase the Senior Exemption for real property by \$500.00 All "Ayes"(see attached)
- j. Mayor Mink motioned to place the same Christmas ad from the Village in the Merchandiser, seconded by Trustee Trimm, all "Ayes"(see attached)
- k. Following the discussion on the use of the LED sign, the board suggested that the Deputy Clerk work on a solution how the sign can be utilized.
- l. Motion was made by Trustee Lonneville,seconded by Trustee Trimm to contract B&N Handy Services to install flooring in bathroom at Fire Hall for the total of \$1342.15 and at the Village Hall , two entry ways and both bathrooms for the total of \$1684.34, all "ayes".(attached invoices)
