The changeover from KVS software to Bas and then Edmunds in Shortsville has been questionable on sewer unit calculation. Mr. Eddington working with Edmund's programmer and the clerk at Shortsville got the unit program downloaded.

The last two Quarters with Edmund's software was found to be wrong. Shortsville owes Joint Sewer in the amount of \$4031.35. After a lengthy discussion, Trustee Fine Made a motion to have Gordon Eddington to check two more previous quarters, which would be Bas software.
