- 5. Siewert Equipment serviced two pump stations (Latter-day Saints) located at the intersection of Outlet Road and Route 21 and on Route 21 across from the Visitor Center. All pumping equipment was serviced and in good running condition.
- 6. Working on Joint Sewer Inter-Municipal Agreement upgrade. There needs to be an agreement in place in order to be DEC compliant.
