- c.) Need to get some quotes from water contractors.
- d.) DPW will start to put up x-mas decoration brackets while weather is decent.
- e.) East Ave. from the bridge out- Town of Manchester will be wedging.
- f.) Skanex started working on the second part of re-lining of the sewer line, Randy will have Kent camera the manhole buried in the cemetery. DPW has to find the manhole for Skanex to finish the re-line.
- g.) The handicapped parking spot that was on Water Street will be looked at after RR work is complete.
